A complete set of bidding documents may be downloaded from PPMO's website www.bolpatra.gov.np/egp e-procurement section. **Bidders shall have the option of submitting their bids electronically only**, For the purpose of bidders to submit their bid electronically, the bidder shall be required to deposit the non-refundable fee of **NRs. 3000.00** in revenue account specified below and electronic scanned copy (*.pdf format) of the bank deposit voucher shall be submitted along with the electronic bid files.

4. Pre-bid meeting shall be held at Baganaskali Rural Municipality at Chirtungdhara, Palpa **at 2077/07/26 (Wednesday, November 11, 2020) at 13.00 hour.**
5. Electronic bids must be submitted to the office at Baganaskali Rural Municipality at Chirtungdhara, Palpa through PPMO website www.bolpatra.gov.np/egp **on before 12:.00 Hours** on **2077/08/07(Sunday, Nov 22,2020)** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13.00 Hours at 2077/08/07(Sunday, Nov 22,2020)** at the office of Baganaskali Rural Municipality, Chirtungdhara, Palpa .Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in (*.pdf format) in case of e-bid, amounting to a minimum of **NRS 360000** which shall be valid for **30 days beyond the validity** period of the bid . If bidder wishes to submit Bid Security in the form of cash, the cash should be deposited in **Deposit account(Darauti Khata) of baganaskali Ga Pa no. 01703000003000000001,** at **Nepal Bank Limited , Tansen, Palpa** and submit the receipt of the deposited amount of cash along with the electronic bid files.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
